TOWN OF FLOYD BOARD MEETING Minutes – October 7, 2025

At 6:00 PM Supervisor Kenneth Eisnor called the meeting to order, stated that all Town Board Meetings are Voice Recorded and led the Pledge of Allegiance.

For the month there were various types of inspections being conducted for some of the new and existing building permits. Continue discussions for chicken coops, ponds, demolition /clean-up of condemned or abandoned houses in the town and cemeteries. Received new 2025 NYS Code books, all new construction after Dec 31st, 2025, is to be all electric, no natural gas, propane, fuel oil, etc.Current ZBA applications include Dyna-Vac new manufacturing building (ON HOLD), expansion of Twin Ponds Park (FUTURE).

Board Comments:

Highway Superintendent Jerome Alexander gave a brief report. Rickmyer Road bridge is completed and opened. The tennis courts have been paved and the basketball hoops just need to be put up. Mckern road has been shouldered and paved. Sand is being hauled, and salt is already on site. Brush pick up is coming up on October 15th and there are two more transfer station days in October. Jerome is looking at a 2025 GMC Sierra 2500, 4 wheel drive, regular cab pick-up truck from Nimey's for the Sanitation Department, It will have a backup alarm, and a plow. The total would be \$61,755 minus the trade in value.

Jerome received the

DOT Annual Certification of Local Highway mileage.

Councilman Daniel Schwertfeger made a motion to approve the purchase of a 2025 GMC Sierra 2500 for a cost of \$61,755 minus the trade in, seconded by Councilman Fred Mazza, carried.

Water Superintendent Michelle Kotary submitted a monthly report.

Attorney Kathryn Festine gave a report. She had a request from Supervisor Eisnor and the Planning Board to amend the scheduling of the Zoning Ordinance, dealing with height limitations for accessory buildings in (RA) Residential Agricultural and Commercial zones limited to 20 feet, where the board and Ken think it would be better for 30 feet. She wrote the law such that the maximum building two stories or 30 feet, in the principal structure or use is in conformance with the zoning ordinance and the height thereof is not less that 35 feet.

Councilman Fred Mazza made a motion to introduce the Local Law Number 4 of 2025, seconded by Councilman Alston J. Huey Jr., carried.

Councilman Robert Evans made a motion to approve a public hearing for Local Law Number 4 of 2025 on November 5, 2025 at 5:30 PM, seconded by Councilman Fred Mazza, carried.

Councilman Fred Mazza made a motion to declare this law an unlisted action for SEQR purposes, seconded by Councilman Daniel Schwertfeger, carried.

She informed the board that National Grid wants to adjust the power lines that go through a cemetery within the town. They gave her a map of their project, and she does not like the way the easement was written. A National Grid representative is going to tighten the language and return it to Kathryn next month.

The Panning Board and Codes Officer have asked if she would be able to amend the storage container law. She gave a copy to the board members and said if they want to go through with it she will prepare a local law for the next meeting.

Town Clerk Tracy Sexton gave a report. There were many hunting licenses sold this month. The revenue was \$3,081 this past month. She said her new software is much easier.

Historian Sally Tagliere gave a report that stated the Floyd Historians met for a Sept. meeting. Even so, they had an informative meeting, learning a bit more about Grover Cleveland, and discussing local cemeteries. October 21 will be their finale meeting date at 5 pm. This will be held at the former Presbyterian Church at Camroden Corners. They needed to schedule earlier for those who don't drive after dark.

Board Comments

Councilman Alston J. Huey Jr. asked if they have approached the Union that they are decertifying from the town since there are no members of the union. Town Attorney, Kathryn Festine is looking into the legalities of how to do this. There are limitations on when the petitions can be brought up. He is asking this because the town is looking to hire new people, and they have the right to be in the Union if it is not decertified. Jerome Alexander said he knows a contact that will be able to help with this, and he will give the name to Attorney Kathryn Festine.

Companies for \$42,000 to line the tennis courts. He is going to advertise in the paper for other quotes in the spring.

Comments from the public:

A town resident on Edwards Rd. raised concerns about his well drying up. He asked if there were any plans to expand the water district and brought up that he has heard that the town may start charging to use the water station. Supervisor Eisnor responded that he does not know how to tell over 900 residents that pay for their water, that the town is giving away water for free. The resident responded that he is paying for the electricity to draw the water up from the well.

Another resident brought up that she is grateful for the water station. She also asked if the town would be willing to bring up the Water District because she would be willing to pay for the water. Supervisor Eisnor said they are looking into it. Ten years ago, they looked into doing this, but the funding was pulled. She is also asking for them to keep the water station open at night for working families or on a Saturday. Supervisor Eisnor said they will discuss this. Highway Superintendent Jerome Alexander said that to expand the water district it would be too expensive for people to afford it without a grant. Whether people want the water or not, they would still have to pay for the piping to go through their land.

Another town resident stated that she was originally able to get city water only because their water was contaminated from Griffith Air Base so therefore that was covered by a grant.

Supervisor Eisnor said that anyone individual can go door to door and petition for the water district. He also said he will try to reach out to the Governor's office and see if there is any funding. He also discussed that they want to open the water station more but in the past residents from other areas were taking advantage of the situation. The board concluded that they are going to open the water station until 8:00 PM on Thursdays. They are also going to discuss opening on Saturdays.

The board also discussed that there was a huge bill for the fire district water. It started when they got the new meter installed. Supervisor Eisnor said that he will look into it and find a solution.
