Minutes – December 30, 2025

At 6:13 PM Supervisor Kenneth Eisnor called the meeting to order, stated that all Town Board Meetings are Voice Recorded and led the pledge of allegiance.

Town Officials present: Supervisor Kenneth Eisnor, Councilmen Alston J. Huey Jr., Fred Mazza, and Robert Evans, Town Clerk Tracy Sexton, and Highway Superintendent Jerome E. Alexander Jr. Absent were Councilman Daniel Schwertfeger and Town Attorney Kathryn Festine.

New Business:

Total Solutions:

We now have a new contract with Total Solutions that is \$500 month and it used to be \$650. Total Solutions is our tech company that helps us with any issues we have with our computers and back up our computers.

Councilman Fred Mazza made a motion to accept the new contract with Total Solutions, seconded by Councilman Robert Evans, carried.

Decrease in Rome Water Bill

The water bill decreased \$9,000 this year versus last year due to the town finding and fixing a major water leak.

Increase in Humane Society Bill

The Humane Society contract will be increasing from \$250 to \$500 due to Governor Kathy Hochul taking funding away.

The board decided not to sign the contract at this meeting. Highway Superintendent Jerome Alexander Jr. is going to look into a different humane society to see if we can find something cheaper.

Approval of Minutes

Councilman Alston J. Huey Jr. made a motion to accept the December 2, 2025 Town Board Meeting Minutes and the December 8, 2025 Town Board Meeting Minutes as presented by the Town Clerk, seconded by Councilman Robert Evans, carried.
