Extreme Weather & Program Cancellation Policy

The safety of all participants, staff, and families is the top priority of the Town of Floyd Summer Park Program. Program activities may be modified, delayed, relocated, or canceled due to weather conditions or other emergencies that may create unsafe conditions. Program staff will closely monitor weather conditions throughout each day using local weather alerts and forecasts.

Conditions that may impact program operations include thunderstorms or lightning, heavy rain, extreme heat or humidity, high winds, air quality concerns, tornado warnings, or other hazardous weather conditions.

During periods of excessive heat or poor air quality:

- Outdoor activities may be shortened or modified, Additional hydration breaks will be required, Activities may be moved to shaded or indoor areas when available, Highintensity activities may be canceled

Parents are encouraged to: Send children with water bottles daily. Dress children appropriately for weather conditions. Apply sunscreen before arrival.

Thunderstorms & Lightning

If thunder or lightning is detected All outdoor activities will stop immediately, Participants and staff will move to a designated safe shelter area, Activities will resume only after conditions are deemed safe by program leadership.

Program Delays or Cancellations

The Town of Floyd reserves the right to cancel or modify program operations due to severe weather or emergency situations.

Parent Notification Procedures

If a delay, early dismissal, relocation, or cancellation becomes necessary, families will be notified through:

- Text messages
- Email notifications
- Town social media pages
- Summer Park Program Facebook group

Emergency Pickup

In the event of severe weather or emergency conditions requiring early dismissal:

- Parents/guardians or authorized emergency contacts must pick up children promptly. Identification may be required at pickup. Children will only be released to authorized individuals listed on registration forms.

The Town of Floyd Summer Park Program operates rain or shine whenever safely possible. Because operational costs are committed in advance refunds will not be issued for interruptions beyond our control. Every effort will be made to provide alternative activities whenever possible.
